Cancellations and Refunds

Cancellation of your participation in this retreat must be made in writing.

We know travel plans sometimes need to change, but as we have to financially commit to the Resort and other service providers we require a 50% deposit at time of booking.

If you cancel **90 days or more** before the start of the Retreat, you will be refunded any sums paid less a \$150 administration fee.
